The University Research Advisory Committee met at 3:30 pm Wednesday, October 7, 2020, via TEAMS, with Dr. Jeff Boles presiding.

1. Approval of Minutes from April 28, 2020

The minutes from the April 28, 2020 meeting were reviewed, with a motion to approve by Dr. Anton and a second by Mr. Godwin. Motion carried.

2. Introductions and Overview of Research at Tennessee Tech

The committee members introduced themselves and discussed their involvement with research at Tennessee Tech. Dr. Taylor offered information to the group regarding the university's research goals. The university is working to double externally funded research, and the University Research Advisory Committee plays an important role in reaching that goal.

3. Strategies for Increasing Externally Funded Research

Dr. Taylor, Dr. Saltsman and Dr. Boles provided information on Tennessee Tech's strategies for increasing research funding:

- Cornerstone Government Affairs Group assists the university in identifying nontraditional funding opportunities. At the beginning of the relationship, Tennessee Tech committed to a one-year trial of Cornerstone's services. Cornerstone helped to secure a \$1 million contract for research funding as a result of a \$30,000 investment in their services. Based on this success, Tennessee Tech reached a longer-term agreement with Cornerstone. Cornerstone is working in this new fiscal year to secure additional appropriation funding. An appropriation is three years, and an authorization is five years. Faculty can support these efforts by developing relationships with peers at government research laboratories as well as administrative staff at these institutions; once these connections are made, Dr. Saltsman can help with identifying opportunities for research at Tennessee Tech that may interest the potential funder. For the current fiscal year, the university asked that white papers be submitted early in Fall Semester to allow for review and prioritization for the best use of Cornerstone's services.
- The university supports research through seed funding programs, such as the Faculty Research Committee Grants. Dr. Taylor spoke about how seed funding programs can be leveraged to support future scholarly activity from a wide range of funders such as foundations, industries, and governments. URAC members have collected information in the past on Tennessee Tech's seed funding efforts, and Dr. Boles will share the information gathered thus far with URAC members.
